Information: Police Department Recruitment and Update	Chief Surber reported 3 – 4 vacancies and shared with the Commission that he is retiring this year. He stated that the Police Chief selection process has been narrowed to 2 finalists whose names have not been released yet, the name of the finalist may not be released until February. He anticipates that the background process will take about 60 days. He discussed the creation of a new "Exceptional Entry Officer" job description that we are working on to allow us to recruit and hire candidates who have completed the Academy but who have little or no experience.
