How Much Water Am I Using?

Water consumption is billed retroactively and rounded down to the nearest thousand gallons. For example, if you use 2,500 gallons between the dates of February 3rd and March 5th, you will be billed for 2,000 gallons on your March 31 bill. The remaining 500 gallons would roll over into the next month. Please note that on your bill, consumption number does not show the last two digits, so 20 gal=2,000 gal.

From the City of Port Townsend's 2025 Budget: Projects & Goals

Water & Sewer Operations

The goal of these enterprise utilities is to work as a business unit to ensure that expenses do not exceed revenues while providing reliable utility services as an essential public service.

2025 Water Division Goals Include:

- Continue replacing aging pipelines to make the system more reliable and minimize distribution system leakage.
- Begin to implement the first year of five to replace all water meters across the city.

2025 Sewer Division Goals Include:

- Implementing new sewer rates.
- Begin implementing key capital projects.
- Work with Jefferson County on expanding septage handling at the Compost Facility

Stormwater Operations

The stormwater collection system includes roadside ditches, wedge asphalt curbs, concrete curbs, rain gardens, and stormwater facilities such as Froggy bottoms.

2025 Stormwater Goals include:

- The Streets division continues to transition the shift of resource investment from vegetation control to street repair. Stormwater management is a key function that needs to be restored prior to street investments. The division work on restoring ditches and making small drainage improvements.

Billing Breakdown

New annual rates are necessary to support the separate business units of Water, Sewer, and Stormwater at the City. Significant investments are needed to maintain and upgrade our aging systems.

Most residential accounts are billed three base fees plus consumption fees. Below is the 2025 breakdown for the standard utilities account: *A single-family residence located within city limits with impervious surface area under 3,000 square feet.* (For all other accounts, please view the 2025 rate sheet on our website.) All rates include taxes.

Water fee:	\$62.85
Wastewater fee:	\$71.60
Stormwater fee:	\$21.51
Urban Forestry fee:	\$0.50
Total monthly base:	\$156.46

Consumption: \$4.67/1K gal

If consumption is 4K or more, there is an additional \$16.91 wastewater fee.

Your paper billing statement currently rolls consumption fees into base rates. If you would like to see an itemized breakdown of your monthly bill, you can view your bill online at CivicPay: cityofpt.merchantransact.com Your CivicPay bill will also include details on adjustments or additional billing.
