Regarding the ESA Section 7 consultation, project action modifications noted below do not cause effects that were not already evaluated in the original Section 7 consultations and would not constitute a change in the ESA effects determinations. Please note that modifications must be documented by the applicant in the post-projects completion report/forms that are required per our FESP Biological Onion with NMFS.

Regarding the NFIP FEMA Region X Puget Sound NMFS BiOp (project within a Special Flood Hazard Area). It is my understanding from speaking with FEMA NFIP staff that the NFIP policy is to accept ESA Section 7 consultations that were completed under a USACE CWA permit or another federal nexus. That said, the project was not specifically reviewed for consistency with the FEMA Region X NFIP Puget Sound BiOp with NMFS. You would need to reach out to the local floodplain administer and any applicable NFIP FEMA staff regarding the NFIP program requirements and NFIP BiOP consistency with the project. If that makes sense? Consultation with NMFS was completed under FEMA's biological opinion (FESP) with NMFS on proposed grant program funded proposed actions (not the NFIP). The NFIP BiOp with NMFS is specific to the NFIP program and local implementation and it has its own requirements. As I noted, this might include

accepting other completed Section 7 consultations (USACE, FEMA PA, etc.), but I cannot speak to this specifically (separate program/insurance related).

As you are probably aware, the NWMC is modifying their scope of work. Specifically, the project NO LONGER PROPOSES:

b. Remove a portion of the armor rock on the intertidal surrounding the stormwater culvert along the SW end of the site. (Adam Tullis describe this as 13 linear feet)

As further described in the JARPA application (Attached) and supporting documents (Geologic Report, Habitat Assessment, Biological Evaluation) design measures include:

- a. Remove rock boulders from the upper beach just NE of the NE end of the concrete stairway near the plaza move to the eroded low bank immediately adjacent above elevation +11 ft MLLW.
 - b. NOW STRICKEN
 - c. Revegetate 356 sf in the upper most beach/backshore with American dune grass (Elymus mollis).

The site is within the FEMA "protected area".

The City is seeking written documentation from agencies with jurisdiction that the project, as Revised, does not alter the previous findings regards ESA Section 7 and FEMA Region X PS BioOp.

FEMA accepted lead via email correspondence with the USACE to complete consultation with NMFS. FEMA utilized our Section 7 NMFS Programmatic Biological Opinion (the link sent to you) to comply with the ESA Section 7 for species under NMFS jurisdiction (PS chinook, PS steelhead, and HC summer run chum, and EFH under Magnuson Stevens act). Our FESP programmatic includes both informal (NLAA) and formal consultation (LAA). ESA Determinations are not completed on a project-by-project basis, but at a program level, based on routine FEMA actions (14 to be specific). NMFS completed a programmatic BiOp, so it issued already, and we submit projects to NMFS for verification, which they review within 30 days and provide verification if they agree with us that the project meets our issued BiOp.

Hi Stacie,

We were contacted by the USACE and applicant regarding FEMA taking lead agency for ESA Section 7 for the above referenced project. It is my understanding from the USACE that the project was submitted to NMFS and was batched with other consultations/projects. The applicant has requested FEMA funding for the subject repair under FEMA WA Disaster 4418, and in an effort to expedite the Section 7 process, we noted that we might be able to take lead and address under our NMFS programmatic.

Do you have any concerns if the USACE withdraws the subject project and FEMA addresses under our FESP programmatic/takes lead?

Project Description: This project is an effort to repair storm damage to the facilities of the Northwest Maritime Center, and to mitigate for future storm impacts by decreasing wave energy and shoreline erosion using strategically-placed large boulders and beach nourishment. The proposed action is to repair the exposed foundations supporting the Northwest Maritime Center's pathway, stairs, first and second floor decks, place beach nourishment to protect the structure against future toe scour, and to place large boulders along the beach to act as barriers to reduce wave and debris impact to deck and pier supports. In addition, armor rock will be removed from the upper beach, dispersed along the low beach (+11 ft

mean lower low water (MLLW)), and an area of 356 ft² will be planted with American Dunegrass along the upper north beach where armor rock is

removed. Due to the in-air noise created from equipment use, the action area reaches 0.4 km waterward, but the project area stays in the upper intertidal zone of the beach. No in-water work will take place.
