

“NO PARKING” AREAS AND AREAS OF LIMITED PARKING DESIGNATED BY CHIEF OF POLICE

Pursuant to Ordinance 3077 (approved June 18, 2012), the Chief of Police designates the following “no parking” areas and areas of limited parking. These designations are effective on July 2, 2012 (the effective date of Ordinance 3077).

1. Two Hour Parking Limits (copied from former PTMC 10.04.190 Two-hour parking limit)

It shall be unlawful for any person to stand or park any motor vehicle continuously at the same place for more than two hours between the hours of 9:00 a.m. and 5:00 p.m. on any day, except Sundays and holidays, on the following described streets of the city:

- A. On Water Street from Harrison Street to Madison Street, and from Madison Street to Monroe Street, on the street side adjacent to and in front of City Hall;
- B. On Taylor Street from Front Street to Washington Street;
- C. On Adams Street from Front Street to Washington Street;
- D. On Washington Street from Tyler Street to Quincy Street;
- E. On Lawrence Street from Polk Street to Taylor Street;
- F. On Tyler Street from Washington Street to Front Street and from Lincoln Street to Clay Street;
- G. On Quincy Street from Washington Street to Water Street;
- H. On Polk Street from Water Street to Washington Street;
- I. On Madison Street between Front Street and Washington Street;
- J. On the 100 block of Quincy Street between Front Street and Water Street;
- K. On “Waterfront Place,” in the area adjacent to Quincy Street and Front Street, to the west and east of, and adjacent to, the Quincy Street dock, and behind the N.D. Hill Building;
- L. On the 200 block of Monroe Street from Water Street to Washington Street;
- M. On Calhoun Street between Water Street and Front Street on the northeast side of the street;
- N. On Fillmore Street between Water Street and Washington Street;
- O. On the easterly side of Grant Street between 7th Street and the driveway entrance to the north;

P. On the westerly side of Sheridan Street from 9th Street to 10th Street; and

Q. On the northerly side of 9th Street from Sheridan Street to Grant Street;

2. Eight-Hour Parking Limits (copied from former PTMC 10.04.192 Eight-hour parking)

It shall be unlawful for any person to stand or park any motor vehicle continuously at the same place for more than eight hours on the following described street:

A. Calhoun Street between Water Street and Front Street on the southwest side of the street.

3. Fifteen-Minute parking (copied from former PTMC 10.04.194 Fifteen-minute parking, with changes).

It is unlawful for any person to stand or park any motor vehicle continuously at the same place for more than 15 minutes between the hours of 9:00 a.m. and 5:00 p.m. on any day except Sundays and holidays, on the following streets of the city:

A. The two parking spaces immediately in front of the entry door into the Waterman and Katz Building, on the 100 block of Quincy Street;

B. The fifth parking space on the west side of Taylor Street south of Water Street;

C. The first parking space on the east side of Taylor Street, adjacent to and north of the parking place reserved for physically disabled persons which is closest to and north of Water Street (at the northeast corner of Taylor Street and Water Street);

D. The second parking space on the west side of Adams Street, closest to and north of the parking place reserved for physically disabled persons which is closest to and north of Water Street (at the northwest corner of Adams Street and Water Street);

E. The first parking space on the east side of Adams Street closest to and north of Water Street (at the northeast corner of Taylor Street and Water Street).

4. Twenty-four hour parking (copied from former PTMC 10.04.200 Twenty-four hour parking)

In the absence of other time limitations, it is unlawful for the owner, or other person in possession of any vehicle, to park or stand, or cause or permit to be parked or stood, such vehicle on any street or public right-of-way in the city for a period of more than 24 consecutive hours, and provided that this section shall apply to city-owned off-street parking areas established as such, and further provided that nothing herein shall prevent the limiting of parking to a lesser period of time, either by ordinance or by order of the chief of police.

5. Other Existing PTMC Restrictions (copied from PTMC 10.04.202 Restrictions, with changes)

- A. Motor vehicle parking is prohibited along the east side of Walnut Street between V Street and W Street. No parking shall be permitted in this area of Walnut Street at any time.

- B. No parking shall be permitted between 11:00 p.m. and 6:00 a.m. on all days of the week along the west side of Walnut Street between the intersections of V Street and W Street.

6. Additional Areas of Parking Restrictions (designated by the Chief, in consultation with the City Manager and Public Works Director)

Parking is limited in the following areas as follows:

- A. No parking space located in the 100 block of Quincy, and no parking in the alley access between the Cannery and the Waterman & Katz Building;
- B. No parking on the east side of Sheridan Street between 19th Street and 20th Street, from mid-block to 20th Street (marked with “No Parking Here to Corner”);
- C. No parking zone at the southeast corner of 10th and Sheridan from the corner to the driveway of the physicians clinic (marked with “No Parking Here to Corner”);
- D. No parking zone on the northern section of 10th Street in the unopened Cleveland Street Right of Way;
- E. No parking zone on the west side of Walker Street, north of the cross walk at Van Ness Street to Blaine Street;
- F. No parking zone on the north side of W Street from Walnut Street to Spruce Street;
- G. No parking around the east corner of Admiralty Avenue and Spruce Street from fence of cemetery to around the corner of the intersection;
- H. No parking after dusk on 49th Street from 53rd Street to the Jersey Barriers;
- I. Two hour parking on south side of Washington Street east of Monroe Street;
- J. No parking on the east side of Sheridan Street from the north side of 7th Street to the south side of 10th Street;
- K. No parking on west side of Kearney Street between Blaine Street and Jefferson Street;
- L. Washington Street between Quincy and Monroe Streets: 2 hour on the south side year round; 4 hours on the north side from May to October; 24 hours from October to May;
- M. No parking on the east side of Monroe Street from Jefferson Street to Lawrence Street;
- N. No parking on both sides of Jefferson Street from Monroe Street to Jackson Street;
- O. No parking on the north side of Washington Street from the west side of Tyler Street to Fillmore Street;

P. Two hour parking on the following City-owned or City-controlled property:

- 1) Mountain View Commons parking lot
- 2) "Back Alley" parking lot (area), located generally off Tyler Street between Water and Washington Streets; except, for one 15-minute parking space at the east end of the parking area

Q. Twenty-four hour parking for the skateboard parking lot (east of Monroe at Washington).

7. Postings Based on Model Traffic Ordinance.

There are various locations within the City that have been posted with certain parking restrictions. The signs generally highlight existing parking restrictions established by the State model traffic ordinance which has been adopted by the City. These sites include parking near certain intersections, driveways, fire lanes, and other locations where the added emphasis of the signs has been determined necessary for safety and clarity to motorists. These sites are not individually identified on this listing but are enforceable when posted.
