

Background: Street Operations

An element of the Comprehensive Street Program and associated with the 2023 Banked Capacity projects is to shift staff resources away from vegetation control to pavement restoration. Recall labor allocations below.



Background – Undeveloped Rights of Way



Each property owner is responsible to the centerline of the right of way



Background – Existing City Codes

- PTMC 12.04.075 Private use of rights of way. This Section identifies expectations concerning minor landscaping in the rights of way and trees in the rights of way
- PTMC 12.12.030 Cleaning of sidewalks
- PTMC 9.08.020 Nuisances impeding sidewalks, debris, infringements of rights of way
- PTMC 12.08 Debris in rights of way
- Revised Code of Washington 35.21.310 Provides authority to municipalities to delegate management of vegetation in the rights of way



Background: Outreach

This change in vegetation maintenance responsibility to the adjoining property owners has been discussed and vetted with the I and D committee meetings for over 1 year associated with the Comprehensive Streets Program. This change has also been discussed with the Parks Recreation, Trees, and Trails Advisory Board with overwhelming support due to the crude nature of the mowing machine and impacts to vegetation and trees.

The City's newsletter has also included an article foreshadowing this change in the February and March Newsletter.

This presentation will also be posted on social media as well as provided in a press release later this spring.



Background: Whole City Participation

Historically, many residents already take care of their street frontage. This shift in practice will involve whole city participation of all property owners rather than those who historically accepted this responsibility. This includes the City. The City will take responsibility for mowing all of the frontage along the City's ownership.


Presentation Objective

- 1. Provide a photo presentation illustrating the responsibility of adjoining property owners to maintain the rights of way frontage.
- 2. Provide a preview of coming code updates to clarify requirements.

Location and Extent

Keep vegetation along the street trimmed to ensure drivers visibility and pedestrian clearance: Vegetation should be controlled with a minimum of 5' and a goal of 10' clear zone from the edge of pavement, 5' clear zone from the ditch line, and 1-2' clear zone from the back of the sidewalk. (This means controlling brush such as snow berries, wild roses, blackberries etc.) Trees should be trimmed up 15' above the roadway and a minimum of 7 ft with a goal of 9 ft above pedestrian paths and sidewalks.



Street Corners

Keep vegetation on street corners trimmed to ensure drivers visibility: Vegetation should be controlled with a 20' clear zone measured from the sidewalk or edge of pavement at roadway intersections.

Sidewalks and Pedestrian Ways

Keep the sidewalk free and clear of obstructions or defects, including, but not limited to, snow, ice, and mud. Trim vegetation to allow pedestrians to pass. If there is parking along side the road, then a clear zone of 5 feet should be maintained beyond the parking location to allow pedestrians to pass around the parked car without walking in the street. Parking areas also need to maintain existing ditch lines for drainage control.



Please make space for pedestrians and wheelchairs by keeping full sidewalk width clear including 1-2 ft behind the walk.

Noxious Weeds

Control noxious weeds - Since noxious weeds easily spread, property owners will need to manage noxious weeds on your property and to the to the edge of street. Noxious weeds are identified per the County weed ordinance. Priority control shall be made for poison hemlock and scotch broom.



Vegetation Mowing and Garbage

Mow and remove garbage - In the area between the edge of pavement in the clear zone described above, mow grass and low ground cover. This includes ditches and the area between the roadway and sidewalk where sidewalks exist.



If you see this after a good wind please pickup and help keep our roadsides clear from garbage.

Mow and remove debris - In the area between the edge of pavement in the clear zone described above, mow grass and low ground cover. This includes ditches and the area between the roadway and sidewalk where sidewalks exist.

Ditches

Keep ditch lines clear - To control drainage and preventing clogging of drains and culverts, all loose vegetation and garbage need to be removed from ditch lines at all times. The City may periodically excavate ditch lines due to sediment from the street. The City also may improve shoulders of the street to ensure water can drain from the pavement to the ditch.





Ditches with debris clog culverts and fill in over time. Vegetation can overtake a ditch



Ditches



Ditch allowed to be overgrown near vacant lot. Will need to be brushed back.

Ditch maintained along with fire hydrant clearance. Thank you!



Ditches



Above. This ditch has been maintained by the City. This responsibility will transfer to the adjoining vacant lot. Below. Ditch between the sidewalk and road maintained by the property owner. Thank you!





Tree Preservation

Preserve Street trees and significant trees - Trees are highly valued by our community. Any work involving pruning, planting, or removal of trees must be permitted through the City. Vegetation control and clearing does not mean removal of trees unless approved by city permit.

Landscaping in the Right of Way



What is allowed in the City right of way (ROW) and when a permit is required.





Summary

- After touring the city streets, 90%+ are in good shape and need to be maintained as they exist today. Most properties with homes on them already maintain the landscaping in right of way adjoining their property.
- The majority of properties in which the City has been maintaining vegetation are vacant properties or double frontage properties. This is where the largest impact will be felt by property owners, especially for larger properties.
- These sets of vegetation maintenance goals set forth a progressive approach to all property owners doing their part to maintain the vegetation in the right of way. Fulfilling this responsibility allows city tax dollars to be spent on streets and drainage rather than vegetation control.



Next Steps

- 1. Staff will continue to put forth public information on the change in maintenance practice and responsibility of property owners.
- 2. Staff will be drafting new nuisance codes with clarity in the definitions and requirements for property owner vegetation control in the rights of way. Staff anticipates new code first reading April 3rd.
- 3. Staff recommends streamline nuisance code, relying on notice and opportunity to remedy the problem with class IV infraction.
